

# **Investment Objective**

The portfolio's objective is to maximise returns in excess of the FTSE JSE SWIX index over time, particularly during periods of weaker equity market growth.

# **Investment Approach**

The Sasfin BCI Equity Fund is a specialist equity portfolio with a "value" bias and will consist of financially sound equity and property securities listed on exchanges and assets in liquid form. The portfolio aims to have a slightly lower risk profile than typical equity funds by mainly investing in shares with a low price to earnings ratio, shares trading at a discount to their net asset value and shares whose prices do not reflect future earnings potential. At all times at least 80% of the portfolio's investments will be in listed equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments.
